RE: Discount End of Offer as of March 28, 2018.

This notice is to officially withdraw the Tariff Discount Offer listed below. March 28, 2018 will serve as the required 30 day notice to end this offer.

Tariff Discount Offer

Nova Scotia Power offers transmission service in accordance with the rates, terms, and conditions contained in its Open Access Transmission Tariff.

A discount to the service in Tariff Schedule 8, item 6 will be offered as per the following:

- ⊕ Service type - Point-To-Point
- ⊕ Class - Non Firm
- ⊕ Increment - Hourly for the **Off Peak** hours only
- ⊕ POR / POD - all posted paths with POD outside Nova Scotia
- ⊕ Offer Start Date - November 2, 2005 beginning at 00:00 Atlantic Time
- ⊕ Offer End Date - Prior notification of 30 days
- ⊕ Price - \$ 1.00/MW base charge
- ⊕ Ancillary Services are not discounted. Only Schedule 1 and Schedule 2 Ancillary Services apply to load served outside the Nova Scotia Operating Area. Current Off-Peak Hourly rates (effective November 1, 2005) are \$0.32/MW and \$0.40/MW respectively.
- ⊕ Total Off Peak Hourly Non-Firm service rate = **\$1.72/MW**

The **Off Peak** period occurs between 00:00 to 08:00 Monday through Friday, and 00:00 to 24:00 Saturdays and Sundays. All times quoted are in Atlantic Time.

The **On Peak** base charge will be \$10.33/MW for Hourly Non-Firm Point-To-Point Transmission Service provided between 08:00 to 24:00 Atlantic Time, Monday through Friday. The Ancillary Service charges will be \$0.32/MW for Schedule 1 and \$0.40/MW for Schedule 2. The total On Peak Hourly Non-Firm service rate = \$11.05/MW (Effective November 1, 2005)

Conditions:

1. The intent of Schedule 8, item 6 will not change except for the offer to discount the Off Peak period as listed above.
2. Nova Scotia Power reserves the right to withdraw or change the discount for service not previously committed.
3. Changes to the discount offer will be posted 30 days in advance.
4. Transmission reservations that are in place prior to the start date will not qualify for the discounted prices.
